FIRST ON THE WATER

Canoes and daffodils usually make their appearance simultaneously, as the lakers wait impatiently for the last snows of the season to disappear. A few tips for these early birds: most canoes have no set front or back. When soloing in a canoe, sit on what is usually considered the front seat facing opposite, towards center. This keeps the prow down, out of the wind. Also, kneeling with your butt braced on the seat is better for your back and gives you more power. If you bring the paddle towards the boat and hold for a split second at the end of your stroke, it may not be an ideal J-stroke, but it does help keep the canoe on course.

ISABELLE'S LEMON PEPPER TROUT One fresh 2-3 lb trout. (We should all be so lucky this April) Melt 1/2 cup butter with 1 medium onion, diced. 1 tsp lemon-pepper, salt to taste.

Split trout and sprinkle inside with onion-butter mixture and seasonings. Fold together and pour balance of butter and seasonings over exterior. Deck with thinly sliced lemon rounds. Bake covered in 350 oven 35-45 mins.

BUD'S BASS TIPS SPRING'S COMING!!

Ultra-light rods are inexpensive and a lot of fun for early spring action, usually 4-6 lb test & spinning reels with short, light rods.

Ultra-lights use small lures--white & yellow grubs with 1/32 to 1/4 lead head weights. Use round heads with hook exposed.

Turbo-tails also work well in the spring. Try white or black/green lures. These will catch crappie, perch and some bluegills. Lots of light hits in the spring.

As the days get longer, the northeast side of the lake will warm and become active sooner (Lodge side towards Clear Run). The breast of the dam (near Marina), will also retain day heat and can be productive.

Sleep late! Best fishing from noon on--in the spring.

ELBOW ROOM!

Lets give the fisherman a break. It's discouraging to have a morning's effort washed away by a pounding outboard. This is a big lake, so when you see someone fishing, how about moving towards center? It would be much appreciated.
