## ANNUAL SERVICE CORPORATION MEETING PROVES ENCOURAGING

The largest number of property owners ever assembled for a meeting turned out for the Third Annual Meeting of Indian Lake Service Corporation Friday, September 30. The full agenda of business began with the reading of last year's minutes and was climaxed by a lively question and answer session.

Other business included a brief discussion of the financial situation of the Service Corporation. The Financial Statement was approved as presented. Jack Butler and Jim Schenck were nominated and elected to serve on the Board of Directors to replace Jack Vanyo and Merle Mellott whose terms expire this year.

The biggest part of the meeting centered on the purposes and objectives of the Service Corporation and the status of the new borough. There is no doubt now that the Service Corporation must assume more responsibility in all affairs of the development.

It was re-emphasized that the Service Corporation is set up as a non-profit organization to administer, with Allegheny Mountain Lakes, Inc., the supervision and regulation of the entire development, which includes the lake and roadways.

There are many advantages to the Service Corporation, and for this reason it must assume a more active role in the development. The important thing is it is run by the property owners for the mutual interests of everyone. Up to now, the two entities have cooperated, and they must continue to do so by extending their efforts to the newly organized borough.

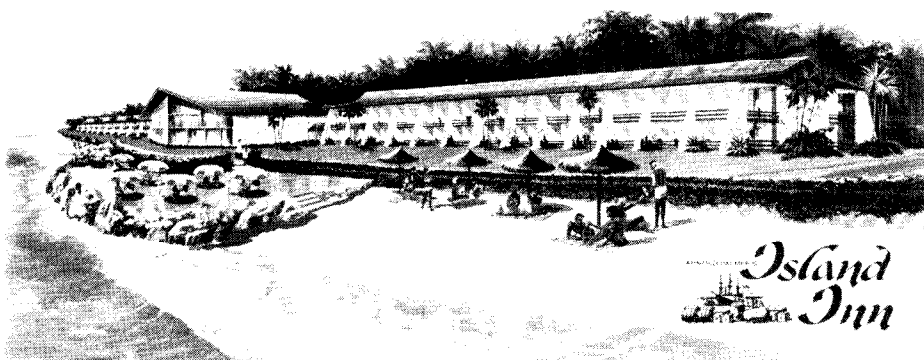
If you will recall, initial action to incorporate as a borough was taken by Allegheny Mountain Lakes, Inc. The borough status was approved by Judge Thomas Lansberry and Indian Lake officially became Somerset County's 24th borough in April, 1966. The first election of officials is set for November 5, 1966. Only permanent residents are eligible to vote, and only if they are registered voters in the township.

While the Service Corporation has many advantages in satisfying the needs of all property owners, it has some disadvantages. Among these is its limitations in law enforcement. Up to now offenders of rules and regulations have been dealt with through friendly persuasion. But now, if necessary, the municipality may use all the means within its power in dealing with all types of misdemeanor acts.

The discussion continued into other areas where unhappy situations may arise as a result of misunderstandings among the three separate organizations. There could be differences of opinions between permanent and non-permanent residents at Indian Lake. A lengthy debate was held on one such subject of conflicting interests; that of school bus transportation. Who will provide the service? The Borough or the Service Corporation? A motion was approved to have the Service Corporation investigate and study costs of bussing and to present the facts at a special meeting Friday, November 18, 1966 at 8:00 P. M. in the Lodge.

Other important questions raised concerned privacy and tax structure. An attempt is being made to have the County Tax Assessment Office reevaluate their methods of assessing properties at Indian Lake to bring

# SKI TALK

With the snow season just around the corner, it's time to start thinking about getting into condition for the active months of skiing ahead. Skiing is a fun sport, but it's also a strenuous sport that requires the use of muscles not used extensively during summer.

To help you get those muscles in shape and ready for an invigorating season on the slopes, I'd like to recommend a few simple exercises you can do in your spare minutes at home or at the office.

To strengthen calf muscles:

- Wearing sneakers, place foot against wall, heel resting on floor, toes and foot pointing up.
- Keep leg straight, hands on hips.
- Bob toward wall until calf muscles begin to pull.
- Repeat eight to ten times.
- Repeat exercise with other leg.

The next exercise can be done while brushing your teeth or putting on make-up. Done five minutes a day your legs will have the added strength they need for a good performance on the slopes.

- Standing straight before mirror place a tape mark at eye level.
- Bend knees until line is reflected over top of head.
- Maintain position while putting on make-up, shaving or brushing teeth.

On final exercise, designed especially for short girls who spend a lot of time in heels, is a good conditioner for knees and ankles.

- Place two books (about one inch thick) two feet from wall.
- Stand barefoot with balls of feet resting on books.
- Rest hands on wall and lean toward it.
- Now do vertical pushups, letting hips push toward wall.

Start conditioning now and you'll be in fine form when the first snows fall. Good luck and I hope to see you on the slopes soon.

social calendar was one of the most splendid ever held at the Lake. After a summer of casual living beside the lake, the formal affair provided a pleasant change.

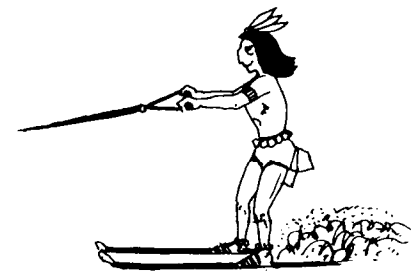
More formals are scheduled for the coming year — be sure to look for them and plan to attend.

Four Indian Lakers were recently awarded honorary lifetime memberships in the American Golf Hall of Fame Association at the Foxburg Country Club, Foxburg, Pennsylvania. Inducted in the association were Jim McIntyre, Winnie and Jim Coleman, and Mert Collingwood. Indian Lake played host in early August to a group of golfers from the Foxburg Country Club, and then were guests of Foxburg later in the summer. The awards were made by the Golf Hall of Fame Association in appreciation of the fine hospitality extended to them during their golf outing at Indian Lake.

The membership includes full privileges of the Association and free admission to the Golf Museum which displays a valuable collection of the very oldest existing golf equipment (leather ball, gutta percha balls, wood putter, etc.) all procured and catalogued by Laurie Aucterlome, Honorary Professional to the Royal and Ancient Golf Club of St. Andrews, Scotland. Also displayed is equipment used by many of the early golfers in the United States.

The Hall of Fame Association has its headquarters in the famous "Log Cabin Club House" of the Foxburg Country Club. The golf course was founded in 1887 and is the oldest course in continuous use in the United States.

them in line with other real estate tax structures. On the question of what affect the Borough will have on privacy of the area, the answer is none, unless when the Service Corporation takes over the rights of the development and would decide to entrust the roadways, etc. to the Borough, it would then become public and could turn into a haven for litter bugs. Indian Lake must remain private if it is to satisfy the needs of everyone.

Actually, with the collection of experienced, informed and educated property owners at Indian Lake, there is no reason to keep this area from becoming a community unique in all the world. Granted, most of you are here to get away from politics, the conflicts of your own community, your work, or just the task of making decisions. But with most cities and towns experiencing difficulties in terms of overcrowding, traffic control, pollution, noise, political strife, and much more, the trend today is toward building new communities . . . not for an escape from the city but to offer a balance of cultural, social and recreational opportunities in a countryside atmosphere. This takes time and cooperation to accomplish.

Communities in this new movement are being built now, and have proven themselves. The most recent and successful ones are located in the eastern United States. Their success has prompted others to believe that communities can be built without the stifling effects in today's cities, towns and boroughs. More clearly, the objective of these new communi-
